Please accept my application for a slip this season. I, (we) agree to the following conditions:

1. A \$200.00 deposit is required with application.
2. Deposits are NON-REFUNDABLE.
3. Lessee may not put their boat in the marina's slip until the rental fee is paid in full. The rental balance must be paid by May 1<sup>st</sup>. If not paid a 1 1/2% service charge will be added each month after this date.
4. Slips are rented by the "Season Only". The season begins on May 1<sup>st</sup> and ends on October 31<sup>st</sup>. A refund will not be given if Lessee vacates his/her slip at any time before end of the season. Slips are NON-TRANSFERABLE.
5. The Anchorage Marina is not responsible for any loss or damage incurred to persons or property due to fire, flood, theft, hurricane, abnormal tides, line breakage, or any cause whatsoever, regardless of negligence or fault, and that Lessee does not carry insurance to cover same.
6. If is further agreed that The Anchorage Marina, Inc. may use any slip while Lessee is away, but slip shall be available up Lessee return. Please notify marina when you will be away.
7. Boats must vacate slip no later than October 31<sup>st</sup>. If boat remains in the water as of November 1<sup>st</sup> they will be charged a fee of \$50.00 per day.
8. The owner is obligated to supply his own mooring lines.
9. All hoses used while the boats are in the dock must be equipped with an automatic shutoff nozzle in working condition.
10. Use of Electric Heaters and Air Conditioners are prohibited except with special permission and a rate of \$125.00. If found using an air conditioner without paying the specified rate, you will be charged a fine of \$500.00
11. Lessee must notify the marina of any change of home address or telephone number.

**Rules:**

Children under the age of 12 must wear a life vest and be accompanied by an adult. Pets must be on a leash at all times. Please be courteous and pick up after your pets. Walk while on marina property. Do not run on or around marina property. Renew dock lines at the beginning of season. Check your boat, especially, during and after storms. When vacating your boat, lock cabin doors and do not leave keys in ignition. While fueling at the fuel dock, close hatches, windows etc. and do NOT smoke. Transporting gasoline on and around marina property is illegal. Do not place driftwood on docks. Do not leave rubbish on docks. Use yard receptacles for rubbish. Do not bring rubbish from home and place in the marina's receptacles. Rowdiness and drunkenness will not be tolerated.

It is covenanted and agreed by the parties hereto that the rules and regulations printed hereof are incorporated herein and made part of this agreement. Any defiance of these the rules and regulations will not be tolerated and can result in eviction from the Anchorage Marina, Inc. and/or legal action, if necessary.
